2. Hazards identification

Statement of hazardous/dangerous nature : Classified as Hazardous according to NOHSC and not classified as dangerous goods according to ADG Code.

Risk phrases : R36- Irritating to eyes.

4. First-aid measures

Eye contact : In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention.

Skin Contact : Flush contaminated skin with plenty of water. Obtain medical attention if symptoms occur.

Inhalation : Remove to fresh air. Obtain medical attention if symptoms occur.

Ingestion : Do not induce vomiting. Rinse mouth; then drink one or two large glasses of water. Contact a doctor or a Poisons Information Centre (Phone: 13 11 26).

Notes to physician : No specific treatment. Treat symptomatically.

5. Fire-fighting measures

6 . Accidental release measures

- Personal Precautions** : Immediately contact emergency personnel. Keep unnecessary personnel away. Use suitable protective equipment.
- Environmental precautions** : Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- Methods for cleaning up** : Stop leak if without risk. Move containers from spill area. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). The spilled material may be neutralized with sodium carbonate, sodium bicarbonate or sodium hydroxide. Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. Note: see section 1 for emergency contact information and section 13 for waste disposal.

7 . Handling and storage

- Handling** : Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Do not breathe vapour or mist. Do not ingest. Avoid contact with eyes, skin and clothing. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Keep away from alkalis. Empty containers retain product residue and can be hazardous. Do not reuse container.
- Storage** : Keep container tightly closed. Keep container in a cool, well-ventilated area.

- Occupational exposure limits** : No exposure standard allocated.
- Engineering measures** : None required. However, use of adequate ventilation is good industrial practice.
- Hygiene measures** : Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. Ensure that eyewash stations and safety showers are close to the workstation location.
